Tim Horton's is on left at the third light, the corner of Hawker and Arthur
Street, across from Canadian Tire.

GENERAL INFORMATION

Entries limited to 9 TD Tracks and 3 TDX Tracks or
equivalent based on 1 TDX = 2 TDs

Confirmation of receipt of entry will be emailed (or phoned) to you.

First test expected to start at approximately 7:00 am.

The draw for tracks will take place at Tim Horton's at 6:15 am. Any
primary entrant who is absent at the assigned time will forfeit his/her position
to the first alternate present.

You MAY enter both the tracking test and the agility trials.

Certification is NOT required to enter a CKC TD test.

All qualifying dogs will be awarded a standard CKC rosette.
Qualifying dogs will also receive a trophy/prize.

Entries must be mailed or sent by courier to the postal address of the test
secretary. Faxed, emailed or hand delivered entries are not acceptable.
More than one dog may be entered, however only one entry per envelope.
Once the trial limit is reached, the trial will be considered full. Entries will
continue to be accepted and will be assigned a position on an alternate list.
The trial secretary will notify all entrants of their acceptance into the trial or of
their position on the alternate list. Should someone withdraw at any time,
alternates will be informed in order of their rank on the list.

Bitches in season CAN compete in the Tracking test, however, the judge will
determine if a bitch in season is to run at the start or finish of the tracks.
Please inform Trial Secretary as early as possible.

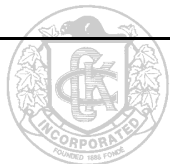
Lunches will be available following the tests back at the concession
